Milestones provides only On-Campus Instruction for the 2022-2023 School Year. Packet pick-up and online assignments are available for students requiring quarantine or isolate.

	Vilestones provided free summer school in June 2021 and 2022 and plans to continue this program in the summer of 2023.
fa s d a s d M	Milestones started utilizing to iReady, an online academic program for reading and math, in August 2020. The program assesses students at the beginning/middle and end of the school year to determine individual academic placement and areas that need academic support. Students are placed on an individual path to strengthen areas of need. Teachers and Administration can use this data to differentiate instruction within the classroom. Milestones also utilizes Dibels assessments to progress monitor student's reading fluency and comprehension needs.

(b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
